CCF Report

This report contains information on the operation of the TCF Code Compliance Framework (CCF) for the period from December 2020 – June 2021.

The information in this report has been compiled by the TCF Compliance Officer for the TCF Board.

Recommendations

It is recommended that the Board:

Overview

- The end of the Compliance Year is 31 March. The certification process was initiated early May this year due to staff handover. Most companies were successful in meeting the deadline for responses.
- The following companies are in breach of compliance due to unreturned annual certification forms for the year ended 31/03/2021. We have confirmed that we will reporting them as non-compliant to the TCF Board and await the return of their completed certification.
 - Symbio Broadband Product Disclosure, Customer Complaints, Emergency Services, Scam Calling.
 - Mobile Messaging Code Bulletin, Connexus, Lateral Corporation and Modica are all noncompliant.

Items to note

In the course of reviewing compliance for the year the Compliance Officer notes the following member companies which are not currently signatories to Codes.

We would expect that these companies should be working towards becoming signatories in this coming compliance cycle.

- Disconnection Code 2degrees
 - o A review of the Disconnection Code is scheduled to commence in August.
- Mobile Messaging Code Spark
 - This Code is currently under review. The review will deliver reasonable changes to the obligations for signatories to the Code, therefore the focus will be on achieving compliance with the companies noted above and Spark once the review process is completed.
- Customer Transfer Fibre Code (non-regulated) Chorus, Trustpower, Vocus
 - These companies have indicated that they will become signatories to the next version of the Code which is currently under review.

Three companies have noted that they are partially compliant with a code on their annual self certification forms that they have filed. These are:

- NOW New Zealand Ltd Disconnection Code and Scam Calling Prevention Code
- Spark Broadband Product Disclosure Code

• Unison Fibre – Fibre Installation Code

NOW New Zealand Ltd and Spark have stated that they are working towards full compliance, and aim to have this completed by the end of July. Unison Fibre noted that they are non-compliant with the need to provide full metric reports, but should be able to provide these moving forward.
