Half Year Report

CCF Report

This report contains information on the operation of the TCF Code Compliance Framework (CCF) for the period from November 2021 – April 2022.

The information in this report has been compiled by the TCF Compliance Officer for the TCF Board.

Recommendations

It is recommended that the Board:

• Note this report.

Overview

• The end of the Compliance Year is 31 March. All companies have now returned their annual self certification forms the current compliance year.

Items to note

In the course of reviewing compliance for the year the Compliance Officer notes the following member companies which are not currently signatories to Codes.

We would expect that these companies should be working towards becoming signatories in this coming compliance cycle.

- Disconnection Code 2degrees
 - o A review of the Disconnection Code is due.
- Customer Transfer Fibre Code (non-regulated) Chorus, Trustpower, Vocus
 - These companies have indicated that they will become signatories to the next version of the Code which is currently under review.

Four companies have noted issues with their compliance over the past year on their annual self certification forms that they have filed. These are:

- 2degrees International Mobile Roaming Code. 2degrees noted that there was a short period during
 the previous year when a small number of customers may or may not have received the SMS message
 required by clause 9.1 of the Code, but that the issue was rectified when identified.
- Chorus Fibre Installation Code. Chorus noted that some of the network operator targets were not met due to impacts from Covid 19 and field services transition.
- Enable Fibre Installation Code. Enable noted that some of the network operator targets were not met due to impacts from Covid 19.
- Trustpower Fibre Installation Code. Trustpower noted they were 2% below meeting one of their RSP targets, due to scenarios which impact their ability to submit orders to the Network Providers, which add manual steps to the otherwise automated process. Trustpower stated that they will continue to work collaboratively with industry and improve internal processes to deliver the best customer experiences, and that they have shown improvement since the previous compliance year.

Code Reviews

New Codes

There have been two new industry Codes published since the last Compliance Report, which have been developed out of the Commerce Commission's Guidelines that were issued to the telecommunications industry on marketing alternative telecommunications services during the transition away from copper-based services (the Guidelines).

The Copper and PSTN Transition Code sets out requirements that RSPs must meet when their customers are transitioning away from copper-based services due to copper withdrawal, PSTN switch off or a commercial decision means copper services will no longer be available in that area. This Code was published on 7 April 2022 and came into effect on 7 May 2022. The following six organisations, including one who is not a TCF member, have opted to become signatories to this Code so far:

- 2degrees
- Mercury
- Prodigi Technology Services Limited
- Spark
- Vocus
- Vodafone.

The Broadband Marketing Code requires providers who market broadband services to ensure that the information about the technical and performance characteristics of the broadband service is presented in a clear, accurate and up-to-date way. This Code was endorsed on 30 April 2022, and the signatory process is currently underway.

Code reviews completed

There have been two Code reviews completed since the last Compliance Report.

The Broadband Product Disclosure Code review has been completed. The updated Code has been published and the Code signatory process is underway, with signatory forms due back by 13 May. This is a mandatory Code so all TCF members are obliged to become signatories. Currently there are two TCF Members who have not yet returned signatory forms:

- NOW
- Symbio

These organisations have both been in contact with the Compliance Officer, and we anticipate the return of their signatory forms shortly.

The Customer Complaints Code has had interim amendments made as part of the TDRS review. The amended Code has been published and the signatory process completed. This is also a mandatory Code, and all TCF members have signed up and completed self certification forms for the amended Code.

Existing Codes under review

The following Codes currently under review by Working Parties.

- Co-Siting Code.
- Customer Complaints Code interim amendments to the Code were made in December 2021 as part of the Commerce Commission review, however the full Code review will be undertaken this year.

- Customer Transfer Code Non-regulated (Fibre) the review of this Code has been completed and the Working Party has approved it to be submitted to the TCF Board for endorsement.
- Emergency Services Calling Code the reviewed Code has been out for public consultation and the Working Party are making final amendments to the Code following consideration of the submissions received.
- Scam Calling Prevention Code.

Codes due for review

In accordance with the TCF's two year Code review policy, the following Codes are due for review. The TCF will prioritise the Code reviews in the coming year. Some Codes will not require any amendment and therefore will rollover to the following two year cycle, subject to TCF member approval.

- Code Compliance Framework
- Product Stewardship Re:Mobile Scheme
- Disconnection Code
- IMEI Blacklisting Code
- Unauthorised Use of Mobile Phones in Prisons Code
